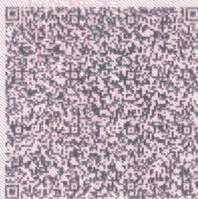

 on 02/12/2024.



**NOW THIS DEED OF TRADEMARK LICENCE WITNESSETH** *as follows:*



## SUPPLEMENTARY AGREEMENT TO TRADEMARK LICENCE AGREEMENT

This Supplementary Agreement to Trademark Licence Agreement (this "Supplementary Agreement") is made on this 2<sup>nd</sup> day of September, 2025 at Ahmedabad

BY AND BETWEEN:

**Mr. Akash Ashokbhai Shah**, residing at 30, Bijalpark Row House, B/H Arhintnagar Society, Gurukul Road, Memnagar, Ahmedabad – 380052, Gujarat, India (hereinafter referred to as the "Licensor/Promoter"),

AND

**SUNSKY LOGISTICS LIMITED** (Formerly known as Sunsky Logistics Private Limited), CIN: U74999GJ2020PLC114376, having its registered office at T.F-316, I Square, Nr. Shukan Mall Cross Road, Science City Road, Sola – 380060, Gujarat, India (hereinafter referred to as the "Licensee/Company").

The Licensor and Licensee shall hereinafter be individually referred to as a "Party" and collectively as the "Parties."

### 1. Background

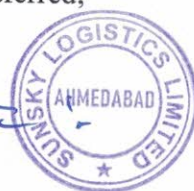
This Supplementary Agreement is executed in continuation of and shall form an integral part of the Trademark Licence Agreement dated 02nd December 2024 ("Principal Agreement").

The Parties desire to record and agree upon the *Right of First Offer* in favour of the Licensee/Company with respect to any proposed grant, transfer, or assignment of rights by the Licensor/Promoter to any independent third party.

### 2. Right of First Offer

**2.1 Notice of Intent:** In the event the Licensor/Promoter intends to grant, transfer, or otherwise assign any rights under the Principal Agreement to any independent third party, the Licensor shall first give a written notice ("Offer Notice") to the Licensee, specifying in reasonable detail:

- The nature and scope of rights intended to be granted or transferred;



- The proposed consideration, key terms, and conditions; and
- Identity of the prospective third party (if identified).

**2.2 Exercise of ROFO:** Within **30 (thirty) days** of receipt of the Offer Notice, the Licensee shall have the right, but not the obligation, to submit a written response ("Exercise Notice") to the Licensors indicating its decision to accept the proposed rights on the same terms and conditions, or to propose good faith negotiations.

**2.3 Negotiation Period:** Upon receipt of the Exercise Notice, the Parties shall enter into good faith discussions to finalise and execute definitive documentation within **15 (fifteen) days** thereafter.

**2.4 Failure to Exercise:**

- If the Licensee does not provide an Exercise Notice within the 30-day period; or
- If after good faith negotiations during the 15-day period, the Parties fail to conclude a binding agreement,

then the Licensors shall be free to grant or transfer such rights to the identified third party.

**3. Conditions Precedent**

- The Licensors shall not execute or enter into any binding arrangement with a third party unless the procedures set forth under Clause 2 above have been complied with in full.
- Any attempted transfer or grant of rights in violation of this Supplementary Agreement shall be deemed null and void.

**4. Miscellaneous**

**4.1** This Supplementary Agreement shall be read with and deemed part of the Principal Agreement. Except as specifically modified herein, all other terms of the Principal Agreement shall remain unchanged and in full force.

**4.2** In case of inconsistency between this Supplementary Agreement and the Principal Agreement, the provisions of this Supplementary Agreement shall prevail.

This Supplementary Agreement shall be governed by and construed in accordance with the laws of India. The courts at Ahmedabad, Gujarat shall have exclusive jurisdiction.
